

SUNSHINE BAKERIES “SHARE THE LOVE, PLEDGE A LOAF TO WIN”

NATIONAL CONSUMER PROMOTION

16 OCTOBER to 14 NOVEMBER 2021

A. ELIGIBILITY

1. This Promotion is open to all Singapore citizens, residents, work permit holders, valid Singapore pass holders and is valid in Singapore only.
2. If you are below 18 years of age, you may participate in this Promotion only if the written consent of your parent or legal guardian is obtained and by participating in this Promotion such consent shall be deemed to have been obtained. The award of any prizes to you in this Promotion shall be subject to the production of the written consent to the Promoter who reserves the right not to award any prizes furnished in this Promotion to you in the event such written consent is not produced.
3. Persons ineligible and excluded from this Promotion are: (a) Employees of Promoter, Sunshine Bakeries and their advertising, fulfilment and promotion agencies; (b) Affiliates and subsidiaries and the immediate families (spouses, and parents, siblings, children and each of their spouses and household members) of each of (a); (c) Persons who are prohibited under the laws of their country of citizenship, residency or domicile to participate in any games of chance and/or skill, or this Promotion.

B. PROMOTION PERIOD

1. The Promotion starts from 00:00 on 16th October 2021 and ends on 23:59 on 14th November 2021 ('Promotion Period').
2. Any entry not received during the Promotion Period shall be automatically disqualified from the participation. The Promoter is not liable for any lost, delayed or misdirected Entries (as defined in paragraph C2 below).

C. HOW TO PARTICIPATE

1. To be eligible to win, participant will have to purchase 1 (one) of Sunshine Bakeries Wholemeal Bread in a single receipt from any stores island-wide during the Promotion Period.

2. Submit the entry via the featured QR code scan (below) and upload a picture of the receipt that shows the purchase transaction must be within the promotion period as stated and product must clearly indicate as Sunshine participating product on the receipt. Every receipt submitted allow participants to “Pledge a Loaf” for Sunshine to donate a Wholemeal Loaf* to appointed charity partners and a chance to participate in weekly lucky draw. *Capped at 10,000 loaves for charity donations.



3. Participants are advised to snap a photo of the Proof of Purchase and keep the original Proof of Purchase for record and/or verification purposes.
4.
